1. GOODS FOR SALE

Newington Markets reserves the right to allow/ disallow vendors to sell goods at the event.

2. TRADING HOURS

All Market stalls are expected to trade from 09.00 am - 2.00 pm.

3. PARKING & ACCESS

Free Parking will be available on the day to traders and customers. We ask that after set up traders please park in the spots furthest from the Market to allow easy access for our customers.

4. STALL SIZE & LOCATION

All Market Stall area is a 3m x 3m site space or as specified in the Market Stall Require Box on page 2. If you require more space please contact the Market Stall Coordinator prior to bump in to discuss requirements. Additional charges may apply. You are required to set up your stall in the most attractive way possible. It is up to the discretion of the Market Stall Coordinator to the removal of any unsightly equipment. The location of ALL Market Stalls is pre-determined prior to Bump IN and will be marked out prior to your arrival. The location is to the total discretion of Newington Markets. Stallholders must bring their own market stall structures and tents must have ALL equipment appropriately weighted (pegged or sand bags) and secured. Market Stall Coordinator will be checking ALL structures prior to Market commencing. Any structure which is not secure will be asked to be removed or will be secured by Newington Markets at the cost to the Stallholder.

All Stall holders MUST provide their own marquee/ tents, tables and product display equipment.

5. INSURANCE

ALL Stallholders must have their own Public Liability Insurance. Copies of your current Public Liability Insurance MUST be submitted with your application.

6. RUBBISH REMOVAL

ALL Stall holders are responsible for the removal of ALL their rubbish and general waste. Recycling and a sustainable attitude compulsory.

7. CANCELLATION & REFUND POLICY

The Market will go ahead regardless of weather conditions, unless deemed dangerous. No refunds will be given if the Stallholder does not attend Market on their own accord.

8. ACCEPTANCE OF TERMS & CONDITIONS
